### **REGISTRAR'S DESK**

After one of the toughest winters on record, I'm sure we were all looking forward embracing the warmer weather of summer. Unfortunately even after such a long tough winter, it seems Mother Nature has decided to keep it going by adding copious amounts of rain that is causing havoc both in Alberta and Saskatchewan. Please join with me in sending our heartfelt prayers and best wishes to everyone in Alberta and Saskatchewan that have been affected by the flooding.



It seems that the issue of cosmetic contacts is still a major concern, and even after being declared medical devices, and being added to Health Canada's regulations of controlled goods, complaints continue to roll in. The college continues to issue letters of warning as complaints are received however; prosecutions are on hold at the moment until the legislation is clarified in the courts with regard to a procedural issue. The college experienced a recent set back at the Court of Queens Bench when the Judge ruled, that we were in the wrong venue and, even though our legal counsel mounted a valid defense to the contrary, the case was sent back to the lower courts to be heard. While the delays are frustrating, it seems the old adage that the wheels of justice turn slowly is actually quite true. Our legal counsel has now received the Queens Bench ruling and has been in contact with the Department of Justice and Attorney General to obtain their assistance as we move forward. In that regard, we have now received input from the Department of Justice and expect the matter to be concluded fairly quickly, after which, the college will move forward with the backlog of cases awaiting prosecution.

As well, a number of housekeeping amendments to the Regulatory Bylaws have been put forward to the Ministry including, the addition of provisions for Prior Learning Assessments. The ability to do prior learning assessments will assist the college in assessing the knowledge, skills and abilities of immigrants and others with prior knowledge and experience in the field of opticianry, that may apply to the college for licensing. The amendments have been finalized, and have now been sent to the Minister of Health for approval, and should come into affect shortly.



# A MEMO TO THE MEMBERSHIP ON CON ED REQUIREMENTS

The SCO encourages all members to keep up to the industry by continuously learning new skills and keeping abreast of new products and processes and will continue to sponsor annual conventions that offer enough con—ed credits for you to maintain the minimum balance required for re-registering.

For those that attend non sponsored events, such as national shows in Las Vegas and New York, or optometric sponsored events, or through on line modules such as those offered by the OAC, the College is prepared to accept and honour those credit hours. However, members are reminded that all education acquired at events not sponsored by the SCO, **require prior approval** or we cannot accept them.

The pre-approval process is relatively simple, and only requires that when a member makes a decision to attend a non sponsored event, the member contacts the SCO office in Saskatoon and provide a copy of the material for review. The College will review the material being offered at the event and pre-approve those seminars qualifying for education credits. The member could also request that the sponsors of the event, forward their material directly to the college for review and approval prior to the member registering for the event. The college would be pleased to review the material being offered at the event and advise the sponsor which seminars can be approved for credits and the amount of credits to be awarded to each seminar.

Some organizations already submit their material directly to NACOR or College for consideration, and as such, members should ask when registering for seminars, whether or not the seminar has received NACOR or SCO approval for accreditation. The College is also in the process of setting up a database to contain a list of the seminars that are pre-approved by the SCO or NACOR for future reference. Members will be able to access this database through the College or the SCO website and view the list of seminars already pre-approved.

### A VISION UP THERE

Jan 25/13, It is -45° Celsius -50° Celsius with the breeze, but the sky is clear, I have never seen a blue, so blue. I am in Chesterfield Inlet, you know, just north of Rankin Inlet. The people are busy, coming and going on foot and on snow machines. They are dressed warm, almost as warm as their hospitality.







There is excitement at the local health centre, the Eye Team Is here. That is what we are referred to up here in the communities. A COMT [Certified Ophthalmic Medical Technologist] working under an Ophthalmologist is doing the eye exams and across the hall I have my frame samples laid out on a table, complete with P.D. ruler, tint samples and as many cleaners and accessories as I can cram into my Pelican travel case. This is my new work place, providing optical dispensing services to the small communities scattered across the Arctic.

The communities all have air service, year round, weather permitting. In summer, most can be reached by ship. This is their only link to goods and services. A CO-OP or Northern general store, are the only shopping opportunities, with internet shopping available to some communities. Prices are high, with usually only one hotel running \$225.00 to \$275.00 per night. Meals, their choice, breakfasts \$35.00, lunch \$45.00 and supper \$50.00 and you have to give them a day's notice. I pack my suitcase full of food!







Polar Vision Centres LTD has two optical dispensaries, one in Yellowknife NT and one in Iqaluit NU on Baffin Island. The Yellowknife location travels to main land Nunavut and the Iqaluit location travels to the Baffin region. Polar Vision Centres LTD is owned by Nunasi Corporation, whose shareholders are the beneficiaries of Nunavut. Our focus is to provide quality optical dispensing services to the people in these regions.

### A VISION UP THERE

The government health care acts in NT and NU do not require licencing for opticians and I am the only licenced optician working up here. In an effort to raise the standard of care for the beneficiaries of NT and NU, we are enrolling five of our seven employees in the NAIT opticians training program this September.

Living in Yellowknife NT is giving me a great opportunity to enjoy the beauty and abundance of nature, which is only five minutes away, along with the warmth and cultural vitality of the aboriginal peoples.





### **OBITUARY**



FRED DALBY
July 22, 1915 - April 5, 2013

With pride, love and respect we recall the contributions Fred Dalby has made to the communities he lived in, the profession he worked in and the people he touched. Fred was a true entrepreneur. He began his 52 year employment with Imperial Optical in 1933 as a messenger for the Saskatoon branch lens laboratory of this international family-owned optical conglomerate. In 1945 he opened as manager the company's laboratory branch in Port Arthur, Ontario (now Thunder Bay). When he left after 17 successful years to join the executive team of Imperial Optical in Toronto it was a known industry phenomenon that every pair of glasses sold in his territory was manufactured by Fred's branch.

At his retirement in 1985 Fred was Imperial's most senior executive employee. Fred was influential in the growth of both the manufacturing and retail ends of Canada's optical industry. He believed in the importance of educating Opticians to a uniform national standard of excellence. Fred became a force of energy driving provincial opticians groups toward achieving self-regulation - legislation which many Opticians take for granted today. Fred would be the first to acknowledge that he did not accomplish anything without the co-operation and collaboration of provincial colleagues and the endorsement of these projects by his employer. But - the glue that provided context and consistency to national projects was Fred. Fred's most important ally was his wife, Isa. Together they blended their dedication to family life with extensive community involvements and Fred's business responsibilities. Fred and Isa agreed the friendships made with customers and colleagues were 'icing on the cake'

Fred believed education and standards were critical for Opticians. He edited, managed and even marked exams for the first Canadian Optician's Independent Study course - The Canadian Guild Course. This was the only training program available to Opticians for many years. Fred recognized that relationships with highly respected educational institutions were key to achieving credibility for Opticians' training and for the profession in general. To see that goal realized Fred worked through the Canadian Guild of Opticians. Fred was honoured by Georgian College for raising funds in excess of the initial goal for the first full time training program for Ontario Opticians. Fred also sat as a member on one of Ontario's early Board of Opticians.

After his retirement from Imperial he became Executive Director of the Canadian Guild of Dispensing Opticians (now called the Opticians Association of Canada) - a national advocacy group for Opticians. Through his business and volunteer networks Fred became a mentor and an inspiration to many Canadian Opticians. Throughout his amazing career, his loyalty to Imperial Optical and to his profession was unshakeable. Many careers blossomed under his direction and their lives were changed forever.

Fred is survived by his daughters - Maggie Somers (Stewart) and Mary Field (Marvin); his granddaughters Amanda Somers and Lindsay Haggerty (Patrick); his step grandson Adam Somers (Katherine) and their children Abby and Graydon. He was predeceased by his wife Isa and by his grandson Brian Field.

Doug lived a very full life but always made time for the real loves of his life, which were his wife, partner and friend Pat, his daughter Cheryl and his son Scott. He was very proud of his family and all of their accomplishments. Doug possessed an infectious sense of humor which found him to be the instigator of countless, harmless practical jokes and pranks that would be accentuated by his unique laugh. He enjoyed Friday night staff meetings and the occasional glass of a fine scotch.

Doug and Pat moved to the Sunshine Coast in 1997 where Doug was a member of the Rotary Club and served on the board of the Sunshine Coast Golf and Country Club. He enjoyed curling and golfing in the beautiful surroundings of his retirement home.

Doug will be deeply missed by his family and friends.


